SAN DIEGO REGIONAL GIS COUNCIL MEETING SUMMARY

Wednesday July 14, 2004

1. Welcome and Introductions - Matt Brown

Matt Brown (County Water Authority) welcomed the group to the SDRGC meeting held at the San Diego Association of Governments. We had a total of 20 people representing 23 agencies and firms (see Attachment 1 for a complete list of attendees)

2. GEONEWS

a) SDRGC Matters - Matt Brown

Wendy Barto (City of Encinitas) has volunteered to fill the Secretary position that has been vacated by Dan Henderson. Dan has taken a new job in the private sector, and according to the San Diego Regional GIS Council Charter only public agency staff are allowed to be Council officers.

b) CGIA Update - Steve Kunkel

The California Geographic Information Association (CGIA) met last May at the Government and Technology Conference (GTC) in Sacramento. New officers were elected to the CGIA Board for a two year term. Board members from the San Diego area are Tom McDowell City of Chula Vista, Rick Sperling Caltrans, Matt Brown County Water Authority, and Steve Kunkel SANDAG.

CGIA also applied for a NSDI CAP grant of \$30,000 to assist with metadata training for the smaller rural government agencies in the State.

c) California GIS Council Update - Matt Brown

d) Web Design Subcommittee - Harry Johnson

The website for the San Diego Regional GIS Council is up and running and can be accessed at www.sdrgc.org. The subcommittee formed to design the website has completed its task and is no longer needed. The website will be maintained by the Council Webmaster. e) GIS Management Subcommittee - Bob Canepa

This subcommittee was tasked with developing a document containing guidelines for implementing, managing, and maintaining a GIS. The subcommittee has completed a rough draft of the document and is meeting on August 4th to review, comment, and revise the draft document. The subcommittee anticipates having a final draft for Council review by the end of the 2004 calendar year.

f) Imagery Subcommittee - Sue Carnevale

The Imagery Subcommittee has been working on developing an Image Acquisition Plan that will foster coordinated, multi-agency image acquisitions in San Diego. The subcommittee is still working on finalizing per agency budgetary cost estimates. A formal Request for Cost Estimates was prepared earlier this year in order to obtain current costs from qualified vendors to prepare the desired digital imagery specified in the Plan. These costs, as well as costs for project oversight/management, QA/QC and delivery of final image products, etc., are being used to derive the per agency budgetary cost estimates.

g) ESRI Host Committee - Matt Brown

VIP passes to this year's ESRI Users Conference are very easy to obtain. Any individual interested in a VIP pass can obtain one at the Registration Desks at the Conference. Identification will be required. VIP passes are valid Tuesday through Wednesday and Thursday till noon. The VIP passes allow access to the map gallery and vendor areas only, not to any of the technical or paper sessions. The Monday night poster social is open to anyone.

The local Host Booth will be set up in the same location as it was last year, with the same banners created by ESRI from last year. Posters of local work efforts are needed for the host both.
