#### 1. Welcome and Introductions

### 3. GEONEWS

A) CGIA Update – Tom McDowell

No new news. Tom will most likely be leaving the CGIA Board by December 31, he is looking for a new municipality representative for the Board.

#### B) High Resolution Imagery Partnership - Tom McDowell

Seven agencies have expressed interest in this imagery acquisition project to date. Currently, they are dealing with finding an agency to lead the project and working on the details of an RFP. The vision is for the lead agency to be contract administrator and accept deposits from participating agencies and make the payment to the vendor. The anticipated schedule is to go to contract July 2008, and fly the area in October 2008. The budget is estimated at \$100/tile or \$500/square mile.

#### C) Homeland Security – Paul Hardwick

The San Diego region received \$11 million from the UASI awards. The North and South Fire Zone Mapping also received funds as did the CAD-to-CAD interagency communication program. The region was also funded for a planning inventory of GIS layers of various agencies, a needs assessment for emergency incidents, and an estimate of emergency GIS network costs.

D) SanGIS Update – Andrew Abouna

The BPR, so far, has led to an improved Landbase update process. There are two proposals out on the future of SanGIS, one is to maintain the City of San Diego and County of San Diego JPA the other is that the County of San Diego would take over the operations of SanGIS. SanGIS Board meetings are open to the public. Contact Andrew for more information.

#### E) National Hydrography Dataset – Andrew Abouna

Andrew thanked Caltrans and ESRI for providing training facilities and software, respectively, for the recent NHD stewardship training sessions. This will help the USGS maintain accurate hydrographic data. Carol Ostegren said that there is no state-level NHD steward in California yet.

Federal agencies use the NHD, therefore it is important for the region to update our area's data.

## 4. SDRGC Elections – Barbara Kent

The goal of this effort is to have local fire codes include wording about digital pre-plan submittals. There is also a PowerPoint show on the web site that will be helpful with talking to planners, fire marshals and developers about the digital submittal guidelines.

# 6. Update on USGS National and State Initiatives and Strategies – Carol Ostegren and Drew Decker

There will be a California GIS Council meeting on October 17.

Carol discussed several topics:

- California Geospatial Framework Draft Data Plan the draft plan is on the CGIA web site and included results from the six workshops held around the state.
- Strategic Planning, Phases 1 and 2 two initiatives were identified for Phase 1: (1) California Spatial Data Infrastructure (CA SDI), and (2) a California Geographic Information Office. Phase 2 details the CA SDI.
