

San Diego Regional GIS Council
Meeting Minutes
October 8, 2008

1. **Welcome and Introductions**

Paul Hardwick welcomed everyone to the meeting. See attachment 1 for a list of attendees.

2. **GEONEWS**

A. CGIA Update – Paul Hardwick

CalGIS/CGIA meets on a bi-monthly basis. Currently there are 3 members on the CGIA Board representing Federal Government, Regional Government, and Businesses in the San Diego region. There are various committees re-forming at present to work on State grants, a strategic plan, and Imagery. At the “More than a Map” conference, State officials made a recommendation to the CIO that a GIO position be created. The recommendation is currently being reviewed by the CIO.

B. Homeland Security Update – Paul Hardwick

C. Imagery Subcommittee – Mettja Kuna

Without enough regional participation, SANDAG will not be able to act as the project lead for regional 4-inch resolution color orthophotography. Currently, the North County agencies are creating a partnership to move forward with the project. The question was asked if the City of San Diego will be purchasing high-resolution orthophotos in the near future. Paul Hardwick said that he’s unsure given the current economic status of the City.

3. **Imperial 2008 Imagery Project – Pat Landrum**

Spearheaded by Imperial County's Assessor's Office, the Southern California Association of Governments (SCAG) acted as the project lead for the acquisition of 6-inch (in urban areas) and 1-foot (in rural areas) resolution imagery. With a budget of \$240,000 and USGS contributing \$40,000 to the project, a Technical Advisory Committee was created to manage the project and QA/QC the product. Caltrans and Imperial County GIS (ICGIS) served on the Committee. Four proposals were submitted and the contract was awarded to Sanborn.

The QA/QC process is finished, and Sanborn has delivered the final product. For FY '09-'10, they are looking to update the urban areas only and potentially obtain terrain data.

The Imperial Imagery Project started in early 2007 with monthly Committee meetings with Imperial County. Please contact Barbara Kent (barbara_j_kent@dot.ca.gov) or Pat Landrum (pat.landrum@dot.ca.gov) at Caltrans with questions about and/or access to the imagery.

4. **City of Poway GIS Program – Brad Rosen**

The City of Poway's GIS Program is currently in the early stages of its development. Without any full-time GIS Staff, Poway has relied on paid and volunteer interns to develop its GIS datasets. In 2006, Poway hired ESRI to perform a needs assessment. Poway is also working with Quartic Solutions to develop their database structure. Poway also purchased Latitude Geographic's Geocortex Internet Mapping Framework for ArcIMS to develop two web mapping applications, PowGIS and E-Zoning. PowGIS is an application used internally by Poway City Staff. For this application, Geocortex created a custom Parcel Property Report. E-Zoning is a public web mapping application that gives its citizens access to zoning information for the City.

5. **Regional Technology Center (RTC) Clearinghouse – Kim Spero**

The RTC was established in 2005 in response to the 2003 San Diego wildfires to facilitate the integration of technology for emergency response. The RTC coordinates with subject matter experts to research emerging technologies and has established a regional clearinghouse, a centralized information resource for public-safety technologies. 6. **Geospatial Technology Center of Excellence (NGTCe) – Ken Yanow, Professor of Geographical Science, Southwestern College**

The NGTCe is a partnership between 7 community colleges and 4 universities whose mission is to improve geospatial technology education to prepare college-level students for geospatial careers. The NGTCe is currently seeking partnerships with educators and geospatial “insiders” and would like a partnership with the SDRGC. Paul Hardwick told Ken that the NGTCe could be added to the SDRGC's e-mail list-serve and could use that as a forum for information.

SDSU also plans on having their own internal event including a poster contest with prizes, a career day, and they are looking to coordinate with Adrienne Perry at the County of San Diego Health and Human Services and possibly the County's Office of Emergency Services. Camp Pendleton plans on having a proclamation signed for GIS Day and will hold 8-9 demos in their Command building, including outreach to elementary schools on base.

Paul Hardwick mentioned that new watershed boundaries for the state have been released. Information about the creation of these new boundaries as well as a layer file of the boundaries can be found under Announcements at www.sdrgc.org.

A question was asked about the current status of SanGIS. The SanGIS Board of Directors was reconstituted last month and had their first meeting recently. SanGIS' status is currently being discussed internally amongst its Board.
