San Diego Regional GIS Council Meeting Minutes January 13, 2016

1. WELCOME AND INTRODUCTIONS

- i. Grace Chung, SANDAG, SDRGC President, welcomed everyone and thanked City of Escondido for hosting and providing refreshments.
- ii. Please see attachment for list of attendees. This meeting was held at City of Escondido, City Hall Mitchell Room.

2. GEONEWS

- a) USGS Drew Decker, USGS, reported:
 - i. The USGS 3D Elevation Program (3DEP) is supporting the generation of new elevation data across the country. USGS issued the FY15/FY16 Broad Agency Announcement (BAA) which solicited proposals for generation of new elevation and requests for matching USGS funds. This is the second round of funding for LiDAR through the 3D Elevation Program. Review of the proposals is proceeding and notifications of the results are likely within several weeks or so. Details on 3DEP can be found on the program's website http://nationalmap.gov/3DEP/.
 - ii. New NHD is now in work for a large Lower Colorado River watershed along the CA and AZ border. USGS is also working further with Los Angeles County on integrating their storm drain network into NHD. The California Department of Fish and Wildlife is also supporting major updates to numerous watersheds across California.
 - iii. USGS is concluding its Hydrography Requirements and Benefits Study (HRBS), which is an assessment of hydrography data needs and benefits. Input was received from federal and state agencies, with a smaller group of local, academic, private, nonprofit, and tribal groups. This will help the agency design improved products and services for hydrography. This study is similar to the National Enhanced Elevation Assessment (NEEA) that USGS did in 2011. Those results led to 3DEP and the LiDAR BAA process now underway. Preliminary results may be out within a month with a final report likely later this spring.
 - iv. USGS has the 2014 Los Angeles County imagery for distribution. The 2014 imagery over the combined Orange County and Riverside/San Bernardino urban area is also available for online download.

- b) **SANGIS UPDATE** Brad Lind, SanGIS, reported:
 - i. SanGIS has created a consolidated DEM and a hillshade from the 2014 data. That data is available from SanGIS (for a small fee to non- participants). Contact SanGIS if you are interested in obtaining either, or both, datasets.
 - ii. The 2014 contours have been published to the Regional Data Warehouse. Due to the size of the data set and certain limitations on shape files, it was necessary to publish the

- contours as multiple file geodatabases (FGDB). Each FGDB is less than 2 GB of data. These are available in the data warehouse now.
- iii. SanGIS has completed a comparison of the SanGIS road network and the Regional Public Safety GIS (RPSG) network. There are some discrepancies but overall the two networks match pretty well. SanGIS and RPSG are taking steps to get the two road layers in sync.
- iv. SanGIS encourages local jurisdictions to contact SanGIS if they would like to start a project to upgrade lots, parcels, roads, and addresses in the jurisdiction. SanGIS recently completed a project with Oceanside that allowed that city to stop maintaining a separate parcel layer.
- v. The SanGIS-SANDAG data warehouse and interactive map will be offline starting on Friday, January 15, 2016 due to power system maintenance at SANDAG. The online services should be back on line by Saturday night.
- c) **SANDAG UPDATE** Grace Chung reported for Pat Landrum, SANDAG:
 - i. SANDAG recently completed an interactive story map, http://transnetmap.sandag.org/. This story map is a showcase of TransNet funded projects including more than 650 highway, transit, bike and pedestrian, habitat conservation, local street repairs, and grant projects and programs.
 - ii. FEMA completed LiDAR acquisition for the central portion of the region. Data is currently being processed. SANDAG applied for a 3DEP-BAA grant to collect LiDAR data for the remaining eastern portion of the region.

3. WORKING GROUP UPDATE

- a) Imagery Working Group Brad Lind, SanGIS, reported:
 - i. Brad thanked everyone for returning their questionnaires on funding and products. The results show that the majority of jurisdictions and agencies are interested in the 9" rural/4" urban 3-band products without oblique imagery. Only 18.5% indicated a preference for the 12" rural/4" urban 4-band imagery through USGS.
 - ii. Certain jurisdictions have declined to participate in the 2016 collection but others have joined in. Based on the added areas the estimated costs for the 9"/3" resolution are: Worst case = \$224/sq mi; Best case = \$166/sq mi; Likely case = \$193/sq mi. The original estimate was at \$194/sq mi.
 - iii. Next steps are to confirm the costs with Pictometry and to get firm funding commitments from participants.
